

Eagle Ridge Academy PSEO Registration

Through the PSEO program, qualified sophomores, juniors, and seniors may attend participating Minnesota post-secondary institutions either full-time or part-time with tuition, fees, and textbooks paid for by the State of Minnesota. Credits earned will be applied to meeting Eagle Ridge Academy graduation requirements.

The PSEO program is designed to: 1) Promote rigorous academic pursuits and 2) Provide a wide variety of options for students beyond the courses offered at ERA. The emotional maturity and level of responsibility of the student is a major consideration for success in the PSEO program. Careful attention should be given to the student's ability to work independently, as well as the student's self-discipline to get to the college or university, to get to classes, and to complete assigned work without close supervision.

Meeting ERA's Graduation Requirements:

Students may take a combination of courses at ERA and the post-secondary institution. Students are responsible for making sure they know ERA's graduation requirements and register for courses that will satisfy them.

Credits:

Students are responsible for having transcripts sent from the post-secondary institution so that comparable credits can be awarded on the high school transcript. A 4-credit college course will satisfactorily meet a full-year credit at ERA. Any questions about comparable courses should be referred to the academic and college counselor **in advance of taking the course to not jeopardize graduation**. All subjects and grades will be recorded on the student's high school cumulative record and will be used in meeting high school diploma requirements.
